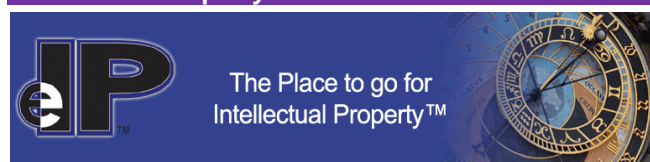
### What can an entrepreneur say in an investor meeting that instantly marks them as an amateur?

The German government itself announced 2 years ago that it wants to have one million electric cars on the road in 2020. Right now, the country boasts a mere 2,300 fully-electric cars. A long way to go.
