CERTIFICATION OF ORGANIC FOOD PRODUCTS

Certification of food products is made in compliance with 834/2007 Regulation (EC) on organic production and labeling of organic products.

Rules for implementing the (EC) 834/2007 Regulation are set out in the 889/2008 Regulation (EC).

Through certification is ensured that organic products are produced in accordance with the requirements laid down under the Community legal framework on organic production, activities performed by operators at all stages of production, preparation and distribution of organic products are subject of a control system set up and managed in conformity with the rules laid down in Regulation (EC) no. 882/2004 of the European Parliament and of the Council of 29 April 2004 on official controls performed to ensure the verification of compliance with feed and food law, animal health and animal welfare rules.

MIŞCAREA ROMÂNĂ PENTRU CALITATE, ACCREDITED BY RENAR, is approved by MINISTRY OF AGRICULTURE AND RURAL DEVELOPMENT (MARD)

Inspection and certification bodies in Romania are approved by MARD to carry out inspection and certification of organic food products in Romania, according to MARD Order no. 181/2012 and are accredited by RENAR, in accordance with EN ISO/CEI 17065:2013.

The overall objective was to strengthen a powerful framework to support transition from school to work of romanian students by counseling and organizing internships in companies from European Union. Therefore, 5300 romanian students received career counseling and guidance through thematic excursions and study visits to organizations in Romania, 200 romanian students performed practical placements in companies located in the European Union and 160 romanian students performed practical placements in companies located in Romania.

The overall objective was to increase the relevance of practical training by promoting collaborative networks between universities and enterprises in the European Union, the opportunities for training in these networks through quality traineeships, supporting the transition from school to working life. Through this project, 450 romanian students benefited of practical placements in companies located in European Union and 90 romanian students performed practical placements in companies located in Romania.


